



Terms and conditions of the Promotional Campaign
“Black Friday Nespresso Professional”
Promotional period: 08.11.2024 – 26.11.2024

SECTION 1. THE ORGANIZER

Nestlé Romania S.R.L., Nespresso Division, with registered office in Bucharest, Str. George Constantinescu nr. 3, Sc. A, Et. 7, district 2, Sole Reg. Code 8184502, registered with the Trade Register Office under J40/10813/2010, bank account RO71CIT10000000724652158, (hereinafter referred to as "**Nespresso Division**") notifies its clients/potential clients about the terms and conditions of the "**Black Friday Nespresso Professional**" promotion.

SECTION 2. PROMO MECHANICS AND CONDITIONS

2.1 Participants

The **Black Friday Nespresso Professional** promo is addressed to all Nespresso Professional customers – exclusively legal entities who have, at the start of the campaign, entered into a contract with Nestle Romania, Nespresso Division, or potential Nespresso Professional customers - exclusively legal entities ('Participants')

2.2 Timing and mechanics

The promotion is valid between 8th of November 2024 and 26th of November 2024 and involves the following:

1. At the time of placing a single order for at least 500 Nespresso Professional capsules (Minimum Order), a 50% discount on the standard price of the Zenius machine will be granted, subject to available stock, along with a complimentary Tasting Kit (a pre-set selection of 56 capsules from the Nespresso Professional range). Therefore, after applying the 50% discount to the full price of the 2230 RON espresso machine, excluding VAT, the price will be reduced to 1115 RON, excluding VAT.
2. At the time of placing a single order for at least 1000 Nespresso Professional capsules (Minimum Order), a 90% discount on the standard price of the Zenius machine will be granted, subject to available stock, along with a complimentary Tasting Kit (a pre-set selection of 56 capsules from the Nespresso Professional range). Therefore, after applying the 90% discount to the full price of the 2230 RON espresso machine, excluding VAT, the price will be reduced to 223 RON, excluding VAT.
3. At the time of placing a single order for at least 1000 Nespresso Professional capsules (Minimum Order), a 20% discount on the standard price of the Momento 100 machine will be granted, subject to available stock, along with a complimentary Tasting Kit (a pre-set selection of 56 capsules from the Nespresso Professional range). Therefore, after applying the 20% discount to the full price of the 6430 RON espresso machine, excluding VAT, the price will be reduced to 5144 RON, excluding VAT.
